SLRAP Guidelines (page 4) state: Throughout the year, TAJF will verify applicants' ongoing eligibility. Dates and LRAP Quarterly Certification deadlines are subject to change by the discretion of TAJF staff.

LRAP QUARTERLY CERTIFICATION INSTRUCTIONS:

Texas SLRAP payments are paid in advance. Recipients are to use the funds received to pay the monthly payments (3) for the upcoming quarter. To receive the quarterly check to be mailed, you must complete the LRAP Quarterly Certification for the preceding quarter by the end of the third month of the quarter. For example if you received a payment for June – August, you must complete the LRAP Quarterly Certification on WebGrants by the end of August in order for the second quarter payment to be timely mailed on the 1st week of September. If it is not completed, then payment will be delayed. Steps for completing the LRAP Quarterly Certification: Log-in to WebGrants, select My Grants from the Main Menu, click on Status Reports, click on current LRAP quarterly certification, under Components select LRAP quarterly certification form, select "yes" or "no" for question 1-6 (#7 is optional to disclose pertinent information to TAJF), click Save, Mark as Complete and hit Submit.
